Green Resources Public Company Limited and its subsidiaries have performance for the nine months period ended September 30th, 2022 and 2021, the consolidated financial statements had total revenues 123.51 millions baht and net loss 32.34 millions baht respectively compared with the same period year the consolidated financial statements had total revenues 150.67 millions baht and net profit 48.11 millions baht the profit decreased by 80.45 millions baht or 167.22%

This was caused by the loss from the decrease in the value of the financial assets invested by the company. From the economic situation in the beginning of the past year to the present

Company and Subsidiary summary total revenues for the nine months period ended September 30th, 2022

and 2021 were 123.51 millions baht and 150.67 millions baht decreate of 27.16 millions baht This is 18.03%

from the same period of last year. This was caused by a decrease in the value of financial assets in the form of

marketable securities such as bonds, ordinary shares, which have declined due to the current economic situation.

2. Cost of sales and services

Costs of sales and services in the consolidated financial statements for the nine months period ended

September 30th, 2022 and 2021 were 57.21 millions baht and 59.58 millions baht respectively, decreased by 2.37

millions baht or 3.98% when compared to the same period of last year. This was caused by an increase in the cost

of real estate sales, which decreased in accordance with the decrease in Cost of rendering of services from

installation of solar-cell system.

3. Selling and administrative expenses

Selling and administrative expenses in the consolidated financial statements for the nine months period

ended September 30th, 2022 and 2021 were 89.85 millions baht and 33.74 millions baht respectively, increase of

56.11 millions baht or 166.30% when compared to the same period last year. This was caused by a loss on the fair

value measurement of a financial asset.

In the nine months period ended September 30th, 2022 and 2021, the Company had a loss on fair value

measurement of financial assets amounting to 26.53 millions baht and loss on disposal of financial assets

amounting to 35.17 millions baht.

4. Owners of the Company

Sharing the results of the owners of the Company in the nine months period ended September 30th, 2022

and 2021, the owners of the Company has loss of 32.34 millions baht and profit of 48.11 millions baht

respectively, Profit decreased 80.45 millions baht or 167.22% from the same period of last year. The company

does not share profits from its operations in subsidiaries because there are no other shareholders.
