2. Cost of sales and services

Costs of sales and services in the consolidated financial statements for the year periods of the

three month period ended March 31st, 2021 and 2020 were Baht 15.18 and Baht 12.24 million, respectively,

increase by Baht 2.94 million or 24.02% when compared to the same period of last year. Since most the cost

of installing a solar power generation system which varied according to the revenue in the said business.

3. Selling and administrative expenses

Selling and administrative expenses in the consolidated financial statements for the year

periods of the three month period ended March 31st, 2021 and 2020 were Baht 9.10 million and Baht 10.04

million, a decrease of Baht 0.94 million or 9.36 % when compared to the same period last year. Because the

administrative expenses decreased according to the company's expense control policy.

Separate financial statements in three month period ended March 31st, 2021 the Company has

set allowance for impairment of investment of 5.17 million baht, increasing expenses from 2020 by 4.27 million

baht.

4. Equity of the owners

The owners of the Company for the three month period ended March 31st, 2021 and 2020 has

profit of Baht 37.47 million and Baht 0.74 million respectively, Profit increased Baht 36.73 million, or

4,963.51% from the same period of last year. Because the company's business expansion in the renewable

energy sector, the sale of equipment and installation, Gain on measurement fair value of financial assets,

reduced operating expenses from the same period of last year and there is no profit sharing from the operation

of the subsidiary because there are not other shareholders.
